5 LATE BIDS

- 5.1 Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter.

6 PAYMENTS

- 6.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.
 - 6.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.
 - 6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.
 - 6.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.
 - 6.1.4 Payment shall be made by bank transfer into the Contractor's back account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the bid is awarded).

TERMS OF REFERENCE

THE QUOTATION OF THE WEB HOSTING SERVICE PROVIDER FOR 3 YEARS

1. BACKGROUND

The NEMISA (National Electronic Media Institute of South Africa) was established as a non-profit institute for education in terms of the Companies Act (1973) and is listed as a Schedule 3A public entity in terms of the Public Finance Management Act (1999). NEMISA, in its pursuit of digital transformation, is seeking a web hosting service provider to manage the institute's websites. NEMISA derives its mandate from the Department of Communications and Digital Technologies (DCDT), which was formed after the merger of the Department of Telecommunications and Postal Services (DTPS) and the Department of Communications (DOC).

2. PURPOSE

This document outlines the terms of reference (TOR) for sourcing a web hosting service provider. The chosen provider will host our company's websites for three years, ensuring they are accessible, secure, and operate efficiently. The objective is to select a provider that offers reliable services that meet our specific requirements at a competitive price.

3. SCOPE OF WORK

The selected web hosting service provider will be responsible for the following:

- Providing 24/7 hosting services for our websites
- Unlimited number of websites
- Ensuring website uptime of at least 99.9%.
- Offering customer support services with a guaranteed response time.
- Provide SSL certificates for the websites from a trusted certifying authority.
- Providing adequate security measures to protect the websites from unauthorised access, DDoS attacks, and other cybersecurity threats.
- Offering scalable solutions that adjust bandwidth and storage space as needed.
- Implement regular daily and ad-hoc backups
- Provide a clear disaster recovery plan in case of a disaster, with a schedule to test at least once every six months.

- Provide a test and/or development environment to test plug-in installation, website(s) update or revamp.
- Provide unlimited e-mail accounts and traffic.
- Ensure website plugins and updates are installed, maintained, and updated as needed.

4. OBJECTIVES

The objectives are:

- To ensure the continuous availability and accessibility of the website to users.
- To secure the website and user data from potential cybersecurity threats.
- To provide a scalable hosting solution that can adapt to the organisation's growing needs.
- To ensure quality customer support is readily available to address issues or concerns.

5. INTELLECTUAL PROPERTY AND CONFIDENTIALITY

All content, code, and assets created on the production and development site must and shall remain NEMISA's intellectual property.

Unauthorised use, copying, or distribution of these materials must and shall be strictly prohibited.

6. DURATION

Services will be required for 36 months.

7. DETERMINATION OF SCORE FOR FUNCTIONALITY

The functionality for this ToR is **80%**, and the evaluation criteria and weights for functionality, as indicated in the table below, will apply.

8. REQUIREMENTS FOR THE PROPOSAL

Proposals will receive further consideration if they score at least **80** points out of 100 points on the technical criteria listed above.

The service provider shall provide a detailed quote that includes the activities mentioned above.

9. CONTRACTING

NEMISA reserves the right to appoint one or more service providers (s) to perform all or some of the required functions as it deems necessary.

Bids must be submitted to the Institute on or before 29 July 2025 @11:00am.

NEMISA reserves the right not to award the assignment to the lowest bid.

1 EVALUATION PROCESS

1.1 COMPLIANCE WITH MINIMUM REQUIREMENTS

1.2 COMPLIANCE WITH MINIMUM SPECIFICATION REQUIREMENTS

All remaining bids will be assessed in terms of compliance with the minimum specification requirements.

Bids which do not comply with the minimum specification requirements will be eliminated from further consideration.

1.3 PRICE AND SCM EVALUATION CRITERIA

- 1.3.1 All remaining bids will be evaluated as follows:
- 1.3.2 The 80/20 preference point system will be applied. Points for price and SCM evaluation criteria will be awarded .
- 1.3.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- 1.3.4 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.3.3 or to a lower scoring bid on justifiable grounds.

1.4 ADJUDICATION OF BID

- 1.4.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
