5 LATE BIDS

- 5.1 Bids received late shall not be considered. A bid will be considered late if it arrives even one second after 11:00 or any time thereafter.
- 5.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.

6 PAYMENTS

- 6.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.
- 6.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.
- 6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.
- 6.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.

6.1.4 Payment shall be made by bank transfer into the Contractor's back account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the bid is awarded).

6.2 The Contractor shall be responsible for accounting to the appropriate authorities for its income tax, VAT or other moneys required to be paid in terms of the applicable law.

TERMS OF REFERENCE (TOR)

SOURCING OF TEMPORARY CIPC COMPLIANCE CONSULTANT.

1. BACKGROUND

NEMISA is a national public entity listed under the PFMA and registered as a non-profit Company under the Companies Act 71 of 2008.

2. PURPOSE

The purpose of the RFQ is to appoint a suitably qualified and experienced service provider to assist with:

- i. Updating the NEMISA's CIPC details (in line with the new CIPC requirements);
- ii. Effecting the amendment of directors as per the shareholders' instruction.
- iii. Ensure that NEMISA is compliant with CIPC Non-Profit Organisation (NPO) requirements; and
- iv. Handover the NEMISA CIPC account/customer code to a NEMISA representative.

4. SCOPE OF WORK AND DELIVERABLES

The scope of work will include but is not limited to:

- i. Examine and review NEMISA's current records on the CIPC system and identify discrepancies.
- ii. To update NEMISA's details by preparing and submitting the required documentation, which may include, but not be limited to: registered office address, company secretary office, auditors, contact details, and financial year end.
- iii. Facilitate the directors' amendments, including, the addition of new directors as per the shareholders' instruction, directors' removal, ensuring the required documentation is lodged and ensuring that directors' information is updated accurately.
- iv. Advise on adherence to CIPC regulations for all implemented modifications.
- v. Upon completion, provide certified proof of updating NEMISA's records.
- vi. Handover the customer code/account to a NEMISA representative.

4. COMPETENCY AND EXPERIENCE REQUIREMENTS

- 5.1. Respondents shall clearly indicate the names of the resources that will be allocated to provide the service to NEMISA as well as a comprehensive CV(s) of the proposed resource(s) and previous traceable experience with references, letters and contactable previous clients.

- 5.3. The successful service provider shall provide a proven track record where the same services were provided.
- 5.4 The submitted references and proven track record where the same services were provided shall be within the past five years.
- 5.5 A project plan outlining a timeline for each submission.
- 5.6 The successful service provider shall draft all forms or resolutions and must be approved by a NEMISA representative prior to submission.
- 5.7 The successful service provider shall submit receipts from CIPC for each lodgement amendment.
- 5.8 The successful service provider shall provide a final confirmation and updated NEMISA's registration document from CIPC.
- 5.9 Respondents shall provide a reference letter with the names and contact details of at least four (4) clients from the public sector for whom the same service was provided during the past five years. **(NB: Purchase orders will not be considered as reference letters)**

6. DURATION

Services will be required for a period of 2 weeks.

7. DETERMINATION OF SCORE FOR FUNCTIONALITY

The functionality for this ToR is **100**, and the evaluation criteria and weights for functionality as indicated in the table below will apply.

8. MANDATORY REQUIREMENTS

Proposals will receive further consideration if they score at least **80** minimum points out of the 100 points on the technical criteria listed above.

9. QUOTE

The service provider shall provide a detailed quote that includes the activities mentioned in item **4.** above.

10. CONTRACTING

NEMISA reserves the right to appoint one or more service provider(s) to perform all or some of the required functions as necessary.

NEMISA reserves the right not to award the assignment to the lowest bid.

1 EVALUATION PROCESS

1.1 COMPLIANCE WITH MINIMUM REQUIREMENTS

- 1.1.1 All bids duly lodged as specified in the Request for Bid will be examined to determine compliance with bid requirements and conditions. Bids with obvious deviations from the requirements/conditions will be eliminated from further consideration.

1.2 COMPLIANCE WITH MINIMUM SPECIFICATION REQUIREMENTS

All remaining bids will be assessed in terms of compliance with the minimum specification requirements.

Bids which do not comply with the minimum specification requirements will be eliminated from further consideration.

1.3 PRICE AND SCM EVALUATION CRITERIA

- 1.3.1 All remaining bids will be evaluated as follows:
- 1.3.2 The 80/20 preference point system will be applied. Points for price and SCM evaluation criteria will be awarded.
- 1.3.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- 1.3.4 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.3.4 or to a lower-scoring bid on justifiable grounds.

1.4 ADJUDICATION OF BID

- 1.4.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
