5 LATE BIDS

- 5.1 Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter.

6 PAYMENTS

- 6.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.
- 6.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.
- 6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.
- 6.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.

TERMS OF REFERENCE

REQUEST FOR QUOTATIONS FOR BOARD AND COMMITTEES' EVALUATION FOR THREE YEARS (2025 – 2027)

1. BACKGROUND

NEMISA is a national public entity listed as a Schedule 3A under the PFMA and registered as a non-profit Company under the Companies Act 71 of 2008. It reports to the Minister of the Department of Communications and Digital Technologies (DCDT).

In line with the Governance Agreement entered into between the DCDT Minister, NEMISA Board and the Committees Evaluation Framework, and Principle 9 of the King IV Report, indicates that the Board must ensure that the evaluation of its performance, its Committees, Chairpersons, and individual Members is conducted annually.

The Board is appointed for three years, and its term will end in October 2027. The annual evaluations are linked to the Board's term.

2. PURPOSE

Over and above evaluating the overall performance of the Board as per the Performance Balanced Scorecard in the Governance Agreement, NEMISA requires the services of an external service provider to determine the following, as per the NEMISA Board and Committees Evaluation Framework:

2.1 The Board:

- 2.1.1 Whether the Board is successfully fulfilling its oversight mandate; and
- 2.1.2 To identify areas of enhancement in improving the efficiency and functionality of the Board.

2.2 Board Committees:

- 2.2.1 Whether the Committees are successfully fulfilling their oversight mandate as per the Committee Charters;
- 2.2.2 Whether the Committees are effectively supporting the Board with aspects or areas delegated to them;
- 2.2.3 To identify areas of enhancement in improving the efficiency and functionality of the Committees; and
- 2.2.4 To identify areas of development while providing lessons learned for the future.

2.3 Board and Committee Chairpersons:

- 2.3.1 If the Board and Committee Chairpersons successfully guide the Board and Committees to perform their core functions and achieve their respective mandates as outlined in their respective Charters.

The current Board comprises six (6) Board members, two (2) executive Directors, being the Chief Executive Officer and the Chief Financial Officer.

There are four (4) Board Sub-Committees as follows:

- A scoping session/discussion will be held online between NEMISA and the service provider to reach a final agreement on the scope.
- A virtual meeting will be held between NEMISA and the service provider to reach an agreement on the tailored questionnaire to be sent to the members.

4. DELIVERABLES

The service provider will provide NEMISA with the following deliverables:

- An annual report containing the results of the Board self-evaluation (“Board Evaluation Report”), highlighting areas of good and satisfactory performance and those that require improvement. The report is to be shared with the Board Chairperson and Company Secretary only unless otherwise notified in writing by the Board Chairperson or Company Secretary.
 - An annual report containing the results of the Committee self-evaluations (“Board Committee Evaluation Reports”). These reports are compiled on the same premise and approach as above. The reports will be shared with the Board Chairperson and Company Secretary unless otherwise notified in writing by the Board Chairperson or Company Secretary.
 - Annual reports containing the results of the Peer Evaluations (“Peer Evaluation Reports”). These reports are compiled on the same premise and approach as above. The reports will be shared with the Board Chairperson and Company Secretary unless otherwise notified in writing by the Board Chairperson or Company Secretary.
 - The annual reports should include each member's skills gap analysis and a recommended Continuous Development Plan.
 - The annual reports should include an Action Plan for the ensuing year based on the outcomes and be tracked until the last evaluation is completed.
 - After the three years, the service provider will be required to produce the three-year close-out report with a comparison of performance over the period.
 - The facilitator will be required to present a high-level overview of the results to the Committees and Board (30 minutes - 1 hour for Committees and 1 - 2 hours for Board).
- The Reports must be in PDF format to ensure version control and integrity.

4. COMPETENCY AND EXPERIENCE REQUIREMENTS

- 4.1. Respondents shall indicate the names of the resources who will be providing the service to NEMISA and a comprehensive CV(s) of the proposed resource(s).
- 4.2. The successful service provider(s) shall have a proven track record in conducting Board Evaluations/Assessments for Schedule 3A companies within the past three years.
- 4.3 Note that the experience of the key resource only shall be considered in the evaluation of this requirement.
- 4.4 Respondents shall provide a list of assignments where similar services for Schedule 3A companies were provided in the past three years.
- 4.5 Respondents shall provide the names and contact details of at least three clients in the public sector for whom a similar service was provided during the past three years.

7. QUOTATION

The service provider shall provide a detailed quotation that includes, but is not limited to, activities mentioned in items **3** and **4** above. The quotation should be separated into three years, and note that the payments will be made in tranches once the evaluations have been concluded in the three years.

8. CONTRACTING

- 8.1 NEMISA reserves the right to appoint one or more service provider(s) to perform all or some of the required functions as it deems necessary.
- 8.2 NEMISA reserves the right to terminate the contract should the outcome of the process and outcomes reports not be at the required standard.

9. CLOSING DATE

1.2 COMPLIANCE WITH MINIMUM SPECIFICATION REQUIREMENTS

All remaining bids will be assessed in terms of compliance with the minimum specification requirements.

Bids which do not comply with the minimum specification requirements will be eliminated from further consideration.

1.3 PRICE AND SCM EVALUATION CRITERIA

- 1.3.1 All remaining bids will be evaluated as follows:
- 1.3.2 The 80/20 preference point system will be applied. Points for price and SCM evaluation criteria will be awarded .
- 1.3.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- 1.3.4 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.3.3 or to a lower scoring bid on justifiable grounds.

1.4 ADJUDICATION OF BID

- 1.4.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
